#### 10. Waa maxay sababta aan u daabcan kari waayay shatigayga?

Waxaa jira dhowr sababood oo laga yaabo inaad u awoodin in aad u daabacato shatigaaga. Waxaa ka mid ah tusaalayaasha ah: Shatigaaga waxaa weli dib u eegid ku sameynaysa magaalada iyo waxa uu ku jiraa xaalada "Codsaday". Ma aad awoodi doontid inaad daabacato shatigaaga ilaa iyo inta laga ansixinayo. Haddii aad isku dayayso in aad daabacdo shatiga sanad ka hor ee magaalooyinka laga cusboonaysiiyo sannad kasta shatiyada, ma aad awoodi doontid in aad sida sameeyso kaddib taariikhda uu dhacay.

#### 11. Halkaan riix si aad u hesho macluumaad dheeraada oo ku saabsan Aqoonsiga Abuuraha.

Waa maxay Aqoonsiga Abuuraha?

Aqoonsiga Abuuraha ama Aqoonsiga Sharikadda waa lambar qaas ah oo lagu aqoonsado bangi ama hay'ad maaliyadeed oo qaas ah ujeedooyinka ku wareejinta elekteroonka dartooda. Waxuu u shaqeeya sidii baaswoor oo kale xisaabtaada bangiga. Waxuu u sheegaya bangigaada inaad ogtahay shirikada asalka ah (shirikada ficilkaas uu ka yimid) ee lacagta xisaabtaada bangiga looga jarayo. Haddii aad siiso lambarkaas bangigaada, waxay ka macno tahay inaad ogtahay in lacag looga jarayo xisaabtaada bangiga hay'adda maaliyadeed ee iska leh lambarkaas. Marka macaamil ganacsi uu ku yimaado xisaabtaada iyada oo uu wato Aqoonsiga Abuuraha, bangigaagu waa ogyahay in aad og tahay waxa u ku saabsan yahay, maxaa yeelay, waxaad iyaga horay u siiyey aqoonsigaas (ID).

Maxaan ugu baahanahay midaas?

Bangiyada qaarkood waxay ka doonayaan Aqoonsiga Abuuraha dhamaanba macaamilka online-ka. Tani waa habka ka hortagga been abuurka si loo hubiyo in qof haysta helitaanka macluumaadka xisaabtaada bangiga iyo macluumaadka lambaradada aanay si sharci darro ah ugala bixin lacag xisaabtaada bangiga. Haddii macaamil ganacsi

uu yimaado xisaabta iyo aadan siin bangigaaga Aqoonsiga Abuuraha hay'adda maaliyadeed ee samaynaysa lacag la bixitaankaas, markaas bangigaagu waxa uu xayiri doonaa macaamilkaas ganacsi. Midaasi adigay ku badbaadinaysaa!

Sidee ku ogaan karaa haddii aan mid u baahanahay?

La xariir bangigaaga iyo weydii haddii ay isticmaalaan lambarka Aqoonsiga Sharikaddii Abuurta si ay ku cadeeyaan lacag kala bixida xisaabta bangiga ee elekteroonka. Haddii uu bangigaadu yiraahdo maya, markaas uma baahnid midna.

Ma waxay tahay inaan midaan sameeyo mar kasta oo aan xareeynayo?

Maya! Markii aad hal mar siiso lambarka bangigaaga, waa dhamaysay. Aqoonsiga Abuuraha hay'adaha maaliyada badanaaba weligii isma bedelo. Haddii uu isbedelo Aqoonsiga Abuuraha keena ama mid ka mid ah Magaalooyinka, waxaanu kugu soo sheegi doona sida ugu dhaqsaha badan ee aanu u ogaano.

Waa sidee haddii aan horay u xareeyay?

Haddii aad soo gudbiso macaamil ganacsi iyada oo aanad ka habsan in bangigaaga uu u baahan yahay Aqoonsiga Abuuraha iyo in kale, macaamilkaaga ganacsi waxa laga yaaba in la diido. Bangigaada la xariir oo weydii oo kaliya.

Halkee ka heli karaa liiska Aqoonsiga Abuuraha?

Riix LOOKUP (EEG) ee xariijinta meniyuuga iyo ka raadi Magaalada aad macaamilka ganacsi ee lacag bixinta online-ka aad ka sameeynaysa. Magaalo kasta waxay leedahay Aqoonsiga Abuuraha u qaas ah iyo qaar waxay leeyihiin labo. Sido kale, waxaa loo baahan yahay inaad siiso bangigaaga Aqoonsiga Abuuraha FileLocal.

Waa sidee haddii aan su'aalo dheerada qabo?

La xariir bangigaaga, Magaalada/Magaalooyinka aad ka xaraynaysa, ama Caawinaada Farsamada.

## **12. Sidee baan ku sameeyan karaa xisaab haddii aan ahay diyaariye, u buuxinaya shirkado badan oo kala duwan?**

FileLocal waxa uu leeyahay xisaab qaas ah oo lagu magacaabo Xisaabta Diyaariyaha. Waxaad ku sameeyan karta Xisaabta Diyaariyaha adigoo riixaya TAX PREPARER ACCOUNT (ABUUR XISAAB CASHUUR DIYAARIYECREATE) ee muraayadda laga galo FileLocal. Markii aad sameeysato Xisaabta Diyaariyaha, waxaad ku dari kartaa macaamiishaada, haddii ay xisaabtooda horay uga sameeyteen FileLocal iyo haddii kaleba. Markii uu macmiilkaadu kuu oggolaado inaad u maareeyso xisaabtooda, markaas waxaad ku gali kartaa adigoo isticmaalaya aqoonsigaaga iyo halkaas ku xareeyn karta canshuur celinta macmiilkaas. Haysashada Xisaabta Diyaariyaha waxay ku oggolaanaysaa inaad u isticmaasho hal aqoonsi liiska macaamiishaada oo dhan.

## **13. Halkee ku xareeyn karaa foomanka canshuur celinta shirkado badan?**

Haddii shirkadahu wadaagaan Aqoonsiga Canshuurta Federaalka (Fein) iyo UBI Koowaad oo isku mid ah (UBI-9), waa in aad u sameeysaa hal xisaab ganacsi oo ay ku qoran yihiin goobaha kala duwan ee shirkadaha.

Xisaabta Diyaariyaha waxay kuu oggolaanaysaa inaad ku gasho hal aqoonsiga si aad ugu maareeyso xisaabaadka shirkadaha kala duwan.

#### 14. Maxaanan u badeli karin UBI-ga?

Marka aad dhammayso sameeynta xisaabtaada, ma aad awoodi doontid in aad beddeshid lambarka UBI ee FileLocal. Maxaa yeelay, UBI Koowaad (UBI-9) waxuu isku xirayaa dhamaanba goobahaaga iyo dhammaan magaaloyinkii ka qeybgala FileLocal ee aad ka ganacsato, beddelida UBI waxay yeelan karta saamayn xeel dheer, qaasatan bacdamaa aanu u isticmaalno lambarkan in aanu ku aqoonsano ganacsigaaga. Sababtaas daraadeed, waxaad u baahan tahay inaad la xariirto magaalada ama magaaloyinka aad ku ganacsato si aad u codsato inay dib u habeeyaan lambarkaaga UBI.

#### 15. Ma soo xareeyn karaa foomanka canshuurta anigoon lacag bixinayn?

Haddii canshurta foomka xisaabteedu tahay eber ama qiime ka sii hooseeya oo kaliya. Haddii foomka canshuurta xisaabitu muujinayo qiimaha xawaaladaha wanaagsan, waa in aad bixisa lacag bixin buuxda inta lagu jiro mudada howsha lacag bixinta ama foomkaaga canshuurta lagama xareeyn doono magaalada.

#### 16. Sidee baan ku soo xareeya foomka canshuurta ganacsiga leh meelo badan?

Marka hore, ku dar ganacsi walba xisaabtaada muraayadda Kudarida goobaha.

Marka xiga, mowskaaga dul saar xariijinta meniyowga ee MY FORM (FOOMKAYGA). Ka dooro FORM SETUP (DHIGAAL FOOM) meniyowga hoos u soo degay. U samee foomanka canshuurta oo cusub hal goob. Haddii doorashada isku aruurinta goobaha ay ku muuqato waxaad dooran karta inaad goobahaaga iskugu wada geysa hal goob oo saldhiga oo aad ku wada bixiso (lambarka xisaabta). Haddii aadan doonayn in aad isku wada aruuriso goobahaaga ka tago qeybtaas iyo sii wad inaad sameeyso foomka goobtaada. Riix batoonka ADD FORM (KU-DAR FOOMKAA). Foomkaaga canshuurta ayaa shaxda ka muuqan doona.

Marka sadexaad, u xaree foomankaaga canshuurta sidii caadiga ahayd. Riix CREATE FORM (ABUUR FOOMKA) ee xariijinta meniyowga iyo ka dooro mid doorashooyinka meniyowyada hoos u soo degay. Riix batoonka NEXT (XIGA) si aad u sii wado xareeynta foomanka canshuurta hal goob oo ganacsi. Ku celi habkaas si aad u sameeyso feylka foomanka cashuurta goobaha kale. Haddii aad iskugu wada aruurisay goobahaaga boga sameeynta foomka, goobtaada isku aruurisay ayaa ku muuqan doonta markii aad tagto faylka foomka iyo halkaas ku bixi canshuurtaada.

#### 17. Ma keydsan karaa foomka canshuurta iyo sii wadi karaa xareeyntiisa waqti dambe?

Haa. Si aad u keydsado foomka canshuurta, riix batoonka SAVE AND CONTINUE (KAYDI OO KA SOCO) ee halka hoose ee muraayadda foomka canshuurta. Si aad u sii wado foomka canshuurta oo keydsanaa, riix MY FORMS->ACTIVITY CENTER (FOOMAMKAYGA->XARUNTA HAWLAHA). Ka dooro mudada xareeynta meniyowga hoos u soo degay. Riix batanka CONTINUE (KU SOCO) ee xariijinta foomka cashuurta.

## 18. Sidee ku daabacan karaa foomankayga canshuurta?

Dul mari falaarta meniyowga My Form dusheeda iyo riix ACTIVITY CENTER (XARUNTA HAWLAHA). Kaddibna ka dooro mudada xareeynta foomka cashuurta meniyowga hoos u soo degay. Foomamka cashuurta ee laga xareeyay FileLocal oo Kaliya ayaa la soo bandhigi doonaa. Riix batoonka VIEW ee ku xiga foomka canshuurta aad doonayso inaad daabacato. Foomka canshuurta waxaa uu ku furmi doona PDF viewer iyo kaddib ayaa la daabaci kara.

## 19. Waa maxay noocyada lacag bixinta laga heli karo FileLocal?

Waxaa jira laba hab oo lacag bixin oo la heli karo. Lacag bixinta habka ACH Debit waa lacag bixinta lagu sameeyo xisaabta bangiga ee jeega ama keydka. Marka aad bixiso macluumaadka xisaabtaada bangi, magaaladu waxay ka jaranaysa lacagta xisaabtaada bangiga. Habkaan lacag bixintu waxa uu la mid yahay jeeg ku qoritaanka electeroonka. Waxaa inaa dheer, lacag bixinta kreditkaarka ayaa la isticmaali karaa iyadoo lagu bixin karo kreditka ama debitka.

## 20. Anigu waxaan soo xareeyay foomka canshuurta iyo sameeyay lacag bixintii, laakiin lacagtii weli lagama goosan xisaabteeyda bangiga. Sababta?

- Kaddib Arbacada 5 galabnimo PST ilaa Khamiista 4:59 PM PST waxaa laga saari doonaa habeenbadhkii habeenka Khamiista PST.
- Kaddib Khaiista 5 galabnimo PST ilaa Jimcaha 4:59 PM PST waxaa laga saari doonaa habeenbadhkii habeenka Axada PST.
- Kaddib Jimcaha 5 galabnimo PST ilaa Isniinta 4:59 PM PST waxaa laga saari doonaa habeenbadhkii habeenka Isniinta PST.

Ugu danbayn, kula tali macaamilku inuu riixo xiriiriyaha helitaanka iimaylka diyaariyaha si uu u tago FileLocal iyo ugu oggolaado codsiga helitaanka shaqaalaha. Macaamilka waxaa laga yaaba in la weydiisto inuu soo saxiixo si uu u helo gelitaanka nidaanka.

Haddii macaamilkaadu uu isagu doonayo inuu sameeysto xisaabtiisa, u tilmaan inuu riixo CREATE BUSINESS ACCOUNT (ABUUR XISAAB GANACSI) kaddib markii uu galo muraayadda FileLocal.

Haddii aad horay u soo codsatay inaad maarayso xisaabtooda laakiin ay weli ka muuqato "Xayiran" liiska macaamiishaada, markaas macaamilkaadu weli ma ansixin inaad u noqoto diyaariyaha. Macaamilkaagu waa inuu helaa iimayl markii ay codsadeen inaad u maarayso xisaabtooda, iyo waxa kaliya oo ay u baahan yihiin inay raacaan tilmaamaha fariinta iimaylka si ay ku siiyaan fasax.

**26. Anigu mar dambe ma ihi diyaariyaha ganacsiga. Sidee isaga saaraa xisaabtooda?**

Home page-kaaga, ka fiiri liiska macaamiishaada. Ka raadi ganacsiga aadan mar dambe diyaariyaha u ahayn, riix batoonka REMOVE (KA-SAAR) ee xaga midig. Ganacsigaas waa laga saari doona liiska macaamiishaada iyo waxa uu diyaar u ahaan doona inay maamulaan canshuur diyaariye ama diyaariye kale.

**27. Halkee ka fiirin karaa liiska isticmaalayaasha loo oggol yahay xisaabteeyda?**

Xariijinta meniyowga, maawaska dul saar ACCOUNT CENTER (XARUNTA XISAABTA), kaddibna riix MANAGE CLERICAL USERS (MAAREE ISTICMAALAYAAHA KARAANIYIINTA).

**28. Waa maxay sababta aanan uga dooran waayay faylka foomka canshuurta boga Foomka Cusub?**

Waxaad u baahan tahay inaad uga soo darto foomka canshuurta shaxdaada dhisitaanka Foomanka ka hor inta aadan xarayn foomkaas canshuurta. Si aad foom ugu darto shaxda Dhisitaanka Foomka, ful saar calaamada mawaska xariijinta meniyowga ka sareeya My Forms. Ka dooro Form Setup meniyowga hoos u soo degay. Ka dooro macluumaadkaada meniyowyada hoos u soo degay iyo ku qor lambarka xisaabta heshiiska magaalada ay u

qoyndeysay ganacsigaaga magaaladaas. Riix batoonka ADD FORM (KU-DAR FOOMKAA). Foomkaaga canshuurtu waxa uu ka muuqan doona shaxda Dhisitaanka Foomka iyo hada waxaad awoodi doontaa inaad ka doorato boga Faylka Foomka Cusub.

## 29. Waa maxay UBI?

A UBI (Tilmaamaha Ganacsiga Midaysan “Unified Business Identifier”) waa lambar 16-god ah oo ay soo saarto Qeybta Adeegyada Shatiyada Ganacsiga Gobolka Washington. Gobolka wuxuu uga baahan yahay ganacsatada soo buuxiya sharuudaha qaarkood inay diiwaangeliyaan ganacsigooda iyo codsadaan UBI.

FileLocal waxa uu isticmaalaa UBI si uu ku aqoonsado goobta ganacsigaaga, sidaas la adligeed waxaad u baahan tahay UBI goob kasta oo ganacsi si aad u isticmaasho FileLocal. Waxaad soo codsan karta UBI xitaa haddii aadan soo buuxin sharuudaha ugu yar ee gobolka adigoo isticmaalaya xiriiriyaha ku yaal dhamaadka qoraalkaan.

UBI waxa uu ka kooban yahay 3 qeybood:

- UBI Koowaad waa lambar 9-god ah oo lagu aqoonsado ha'yadda cashuur bixinteeda oo dhan, iyadoo aan loo eegin tirada ganacsiga ama goobaha.
- Aqoonsiga Ganacsiga (Business ID) waa lambar 3-god ah oo matalaya ganacsiga. Xaaladaha intooda badan tani waxay noqon doontaa 001, laakiin waxaa suuragal ah in la yeelan karo ganacsiyo badan oo la matalo ilaa iyo UBI Koowaad, sidaa darteed Aqoonsiga Ganacsiga (Business ID) waxa uu noqon kara 002, iwm.
- Aqoonsiga Goobta (Location ID) waa lambar 4 god ah oo matalaya goobta ganacsiga.

Bacdama ay tahay in goob kasta oo ganacsigaada laga diiwaangeliyo gobolka, goob walba waa in ay leedahay lambar 16-god oo UBI ah oo u gaara, oo ka kooban UBI Koowaad ee caadiga (9 lambar ee hore) kaddibna Aqoonsiga Ganacsiga (Business ID) iyo Aqoonsiga Goobta “Location ID” isku darka ah.

Gobolku waxa uu kaa doonayaa UBI haddii aad soo buuxiso 1 ama ka badan sharuudahaan soo socda:

- Daqliga guud ee ganacsigaaga uu yahay \$12,000 ama ka badan sanadkii.
- Aad ku ganacsanayso magac adigoo isticmaalaya magaca aan ahayn kaaga buuxa ee sharciga.
- Aad qorsheynayso inaad shaqaaleyso shaqaale 90 casho ee soo socda.
- Aad iibiso badeeco ama bixiso adeegyo la cansuuro. Si aad u ogaato wax badan oo ku saabsan wax soo saarka ama adeegyada la canshuuri karo, ka eeg Tilmaamaha Cashuurta Waaxda Cashuuraha, ama iyaga ka soo wac 1-800-647-7706.
- Ganacsigaadu waxa uu ku leeyahay shati qaaska ah oo laga heli karo Adeegga Shatiyada Ganacsiga.
- Ganacsigaadu waa shirkad Gobolka Washington, LLC, ama iskaashi kooban ah.
- Haddii aad doonayso inaad furto ganacsi sida Ha'yad, Shirikad Mas'uuliyadda Xadeeysan (LLC) ama Milikiyad Xadeeysana (LP), waa inaad iska diiwaangelisa Xoghayaha Dawladda si aad u hesho lambarka UBI ee ha'yadda sharciga ah.
